On 25 September 2024 Arvida shareholders will vote on the resolution to approve the scheme of arrangement with Stonepeak Alps BidCo Limited in relation to the proposed acquisition of all the shares in Arvida at a price of NZ\$1.70 per share in cash (**Scheme**).
